## Investment Approach & Criteria

---

Capital Z is extremely selective in its investment review and rarely participates in auction processes. We typically complete 1 or 2 transactions per year. A Capital Z investment has an average holding period of approximately 6 years.

### Key Investment Criteria & Requirements:

- Strong management team with complete alignment of interests
- Board representation at the outset of every transaction
- Financial services companies in North America, the U.K., Bermuda and other select geographies
- Typical investment size of \$25 million-\$75 million per transaction from our committed capital base, but with our co-investor relationships we have the ability to execute significantly larger transactions
